DRIVING DIRECTIONS:

FROM BALTIMORE AREA: Take I-695 (Baltimore Beltway) to Route 97

South towards Annapolis. Stay on I-97 until it ends and merges into Route 50. Take Route 50 East exit, stay in the right lane to take the first exit, #22 Route 665 (Aris T. Allen Blvd /Riva Road). Turn right onto Riva Road and proceed to the second traffic light, Harry S. Truman Parkway. Turn right onto Harry S. Truman Pkwy., proceed 1/2 mile and the building will be on your right. Across the street from the AA County Health Department
