Directions:

From Phila – Take I-76 East (Walt Whitman Bridge) and merge onto NJ-42S. Take Exit 10A to merge onto NJ-168S/N Black Horse Pike. Turn Right at Lakeland Road. Turn Right at County House Rd/Woodbury-Turnersville Rd N. The Training Center will be on your left – 420 N Woodbury-Turnersville Rd.

From Trenton – Take I-295 South and exit onto NJ-42 South. Take Exit 10A to merge onto NJ-168S/N Black Horse Pike. Turn Right at Lakeland Road. Turn Right at County House Rd/Woodbury-Turnersville Rd N. The Training Center will be on your left – 420 N Woodbury-Turnersville Rd.

From Commodore Barry Bridge – Take the ramp onto US-130 North and merge onto I-295 North. Take Exit 21 toward Woodbury/National Park. Follow signs for Woodbury E/County Rd 640 E and merge onto County Rd 640/Delaware Street. Continue onto Cooper Street/County Rd 706. After you pass the Deptford Township Municipal Building, take slight right at County Rd 534/Good Intent Rd. After you cross the bridge over Rt 55, take a slight right at County House Rd/Woodbury-Turnersville Rd N. Continue on County House Rd/Woodbury-Turnersville Rd approximately 2 miles and the Training Center will be on your right – 420 N Woodbury-Turnersville Rd.

From Atlantic City – Take the Atlantic City Expressway West (partial toll) and merge onto NJ-42 North. Take Exit 7 toward County Rd 534/Route 705/Sicklerville Rd/Woodbury-Turnersville Rd. Turn right and continue on County Rd 534/Route 705/Sicklerville Rd/Woodbury-Turnersville Rd. Continue to follow County Rd 534. Continue onto County House Rd/Woodbury-Turnersville Rd for about 1.5 miles. The Training Center will be on your left – 420 N Woodbury-Turnersville Rd.

From NJTPK – Take Exit 3 and merge onto NJ-168 S/N Black Horse Pike toward Woodbury. Continue on the Black Horse Pike through Blackwood. Turn right at Lakeland Road. Turn right at County House Rd/Woodbury-Turnersville Rd N. The Training Center will be on your left–420 N Woodbury-Turnersville Rd.
